# 17 Healthcare Workers Honored by Ceca Foundation

Recognizing the Extraordinary Service of Frontline Caregivers Fighting Coronavirus

**WASHINGTON, DC, May 29, 2020**—Ceca Foundation is pleased to honor 17 exceptional healthcare workers with a Special Award introduced last month by the organization. The ongoing series of Special Awards are designed to recognize acts of care on the frontlines and behind the scenes during the COVID-19 pandemic. These 17 individuals join the other caregivers that were previously honored, bringing the total to 28 awards.

"Every employee throughout our network of hospitals, skilled nursing, and integrated care communities has stepped-up in meaningful ways to protect patients, senior residents, and one another from the devastating effects of coronavirus," said Nate Hamme, President of Ceca Foundation. "These essential workers are jeopardizing their own health and personal lives on a daily basis—and while all of these employees deserve our thanks, we are pleased to highlight these 17 in particular with our Special Award."

The following caregivers are being honored with the second round of Special Awards:

#### Washington, D.C.

- Cheryl Lucas, Assistant Director of Nursing, Army Distaff Center at Knollwood, Washington, DC, for perseverance in serving as the front-line infection control nurse, testing hundreds of residents, providing updated information, comforting family members, and communicating hope during this pandemic.
- Arlette Kesseng A Mbassa, Director of Nursing, Army Distaff Center at Knollwood, Washington, DC, for her dedication, sacrifice, commitment, and leadership providing front-line nursing care during this pandemic. There are no self-distancing, work-from-home, or telehealth options for nurses, and Arlette comforts the fearful, swabs for samples, guards the PPE, responds to daily DOH requests, and constantly educates and advocates for her team.
- **Portia Richardson,** Medical Records Director, Stoddard Baptist Global Care, Washington, DC, for her attention to detail in working with regulatory bodies, for organizing and promoting facility events that bring peace to the community, and for her warmth in managing relationships with physicians and funeral homes.

• **Carrie Buzzo**, Clinical Supervisor at West Virginia Caring, Arthurdale, WV, for her calm demeanor in empathizing with patients and families, ensuring supplies and medications are stocked and ready, and for spending extra time educating staff and residents on the signs, symptoms, and precautions necessary during the pandemic.

Each of these Honorees receives a monetary award of \$250, and all are celebrated by their fellow staff members, patients, families, and the Ceca team at their respective healthcare communities during a public and virtual Award presentation over video conference.



Matthew Lawlor, Founder and Executive Chair, further stated, "If there was ever a time to show our appreciation to caregivers, it is now. These are very extraordinary people, and these are extraordinary times."

Ceca, established in 2013 to celebrate caregiver excellence and promote quality patient care, introduced these Special Awards specifically to honor frontline workers and support staff – all defined as caregivers – in the fight against COVID-19 within healthcare communities. The Lawlor family increased its funding and invited outside donors to help underwrite the Special Awards.
